### **New GPP 22: Dealing with spills**

This guidance is for anyone who is responsible for storing and transporting materials that could cause pollution if they spill. It may also be useful for those who respond to spills, or those responsible for transporting or storing waste from spills.

This guideline gives information and advice about:


- pollution risk assessments;

### **New Legislation**



### Plant Health Order (Northern Ireland ) 2018

This Order comes into operation on the 1<sup>st</sup> December 2018. It consolidates with amendments the Plant Health Order (Northern Ireland) 2006, which contains measures to prevent the introduction and spread of harmful pests and diseases into the EU and the Plant Health (Phytophthora ramorum) Order (NI) 2005 which contains measures to prevent the introduction and spread of Phytopthora ramorum amendments and various amendments to those Orders.

This Order also includes measures strengthening import and movement

requirements for oak trees, to minimise the risk of further incursions of Thaumetopoea (oak processionary moth).

The Plant Health legislation is updated frequently, to take account of new or revised risk assessments, pest interceptions, changes in distribution of pests and other developments.

## Synopsis of consultation responses – draft Fluorinated Greenhouse Gases (Amendment) Regulations (NI) 2018

The Department of Agriculture, Environment and Rural Affairs ("The Department") plans to introduce the draft F-gas Regulations to update the existing F-gas Regulations in order to ensure compliance with further new EU requirements on F-gas provisions. The Department consulted on the draft Regulations from the 31 August 2018 until 26th October 2018 and has now published the synopsis of responses received from stakeholders to its consultation document.

# Consultation on proposed amendments to regulations on the use of Hazardous Substances in Electrical and Electronic Equipment

The Department for Environment Food and Rural Affairs is currently seeking views on updating the restriction of the use of certain hazardous substances (RoHS) in electrical and electronic equipment regulations to bring the amended EU directive 2017/2102 into UK law.

The change will correct some unintended consequences of widening the definition of electrical and electronic equipment products. In particular the change will stop the restriction on the resale and repair of old equipment and clarify issues concerning product scope.

### **Landfill Tax: Increase in Rates**

Landfill Tax was introduced on 1 October 1996 to encourage waste producers and the waste management industry to switch to more sustainable alternatives for disposing of material.

Her Majesty's Revenue and Customs (HMRC) has



publishes guidance on updated charges that will apply to operators of landfill sites in England and Northern Ireland form the 1 April 2019. The rates being amended and the new rates are set out below.

### Now is the time to Soil Sample

The Department of Agriculture, Environment and Rural Affairs has published guidance on the period from October to February as the optimum time for taking soil samples as soils should not be tested within three months of the last application of lime, slurry or chemical fertiliser in order to achieve accurate results. Soil analysis determines the fertility of your soils, allowing you to plan manure and fertiliser applications to maximise crop yield, minimise wastage and nutrient loss and make full use of your slurry and manure.
