# Environmental Protection (Microbeads) Regulations (Northern Ireland) 2018

These Regulations ban the manufacture and sale of rinse-off personal care products containing microbeads.

Microbeads are an avoidable source of aquatic pollution. Up to 680 tonnes of plastic microbeads are used in personal care products in the UK every year, billions are being washed into drainage systems and entering our seas. Microbeads accumulate in the aquatic environment because they do not biodegrade and because it is impossible to recover them once released.

This legislation will reduce the release of plastic into the aquatic environment and lessen harm to aquatic organisms caused by this form of micro-plastic.

The Regulations come into operation on 11<sup>th</sup> March 2019.

### DAERA seeking views on the proposed Nitrates Action Programme

The Department of Agriculture, Environment and Rural Affairs (DAERA) is seeking views on the proposed Nitrates Action Programme for Northern Ireland 2019-2022.

The Nitrates Action Programme implements the EU Nitrates Directive which is designed to protect surface waters and groundwaters from pollution by agricultural nutrients.

DAERA would welcome any comments on the proposals outlined in the consultation document.

The consultation will close at 4pm on 19 March 2019.

# Consultation on Packaging Waste: changing the UK producer responsibility system for packaging waste

The Department for Environment, Food and Rural Affairs is currently consulting on proposals to reform the packaging producer responsibility system. Views are sought on measures to reduce the amount of unnecessary and difficult to recycle packaging and increase the amount of packaging that can be recycled through reforms to the packaging producer responsibility regulations. It also proposes that the full net costs of managing packaging waste are placed to influence its design. In particular, the Department is seeking views on:

- changing how costs are managed to be consistent with "polluter pays" principles
- how we can use incentives to encourage the use of recyclable packaging
- making recycling labels mandatory on packaging
- setting new packaging waste recycling targets for 2025 and 2030
- improving monitoring and enforcement of the regulations

# Consultation on Introducing a Deposit Return Scheme (DRS) for drinks containers (bottles and cans)

The Department of Agriculture, Environment and Rural Affairs, together with the UK and Welsh Government are currently seeking views on proposals to introduce a deposit return scheme for drink containers in England, Wales and Northern Ireland. This would include drink containers such as:

- glass bottles
- plastic bottles
- cans

The cost of the deposit would be added to the price of the drinks included in the scheme when they are purchased. The deposit would be redeemed when consumers return their empty drinks containers to a designated return point. It is anticipated, that if introduced, a deposit return scheme will increase recycling and reduce littering of drinks containers included in the scheme. The consultation is primarily aimed at:

- Businesses that produce, sell or import drinks in single use containers
- Organisations involved in the management and recycling of packaging waste
- Packaging compliance schemes
- Other organisations who have an interest in packaging and how packaging waste is managed in the UK
- The public

### **Consultation on Plastic packaging tax**

HM Treasury is seeking views on the design of a brand new tax which would apply to businesses that produce or import plastic packaging that doesn't include at least 30% recycled content, from April 2022.

### Refrigeration and freezer equipment: How to manage the impacts of the EU Fluorinated Greenhouse Gases Regulation

A ban is coming in to force in 2020 that will prevent refrigerants with a global warming potential (GWP) greater than 2500 being used to service or refill your refrigeration or freezer system. This ban affects refrigeration systems containing HFCs amounting to over 40 tonnes of carbon dioxide equivalent. This equates to around 10kg of R404A, a common refrigerant in medium sized systems.

The type of systems affected will typically include:

- industrial refrigeration systems
- large commercial refrigeration systems, e.g. 'central pack' systems used in supermarkets
- large transport refrigeration systems, e.g. in trains or ships

# A Guide to Consigning Hazardous Waste

The Department of Agriculture, Environment and Rural Affairs has published a guidance document to help explain how to use consignment notes when dealing with hazardous waste.

The purpose of the Hazardous Waste Regulations is to provide an effective system of control for wastes which are dangerous and difficult to handle, to ensure that they are managed from their point of production to their final destination for disposal or recovery. This is achieved by tracking movements of hazardous waste via a Consignment Note system.

# Farmers to note the online submission for Nitrates Derogation records

Farmers who want to be considered for derogation this year must submit their applications to DAERA online. The system is now open for 2019 applications and for the submission of 2018 records.

The submission deadline date is 23:59 on the 31 March 2019, for all Fertilisation accounts from 2018 and applications for 2019.

Please note that Fertilisation plans for 2019 should be prepared by the 1 March and be available on farm from this date. Read more here >>>
