

New Legislation



The REACH etc. (Amendment etc.) (EU Exit) (No. 3) Regulations 2019

This instrument amends the REACH etc. (Amendment etc.) (EU Exit) Regulations 2019. It inserts a new transitional provision relating to applications for authorisations to use chemical substances of very high concern (the "new transitional provision"). It also makes some minor amendments relating to dates, cross-references and recent amendments to EU the REACH regulation.

The Regulations come into force on immediately before exit day.

Each year the greenhouse gas inventory is extended and updated.

GOV.UK: First Review of 25 year Environment Plan published

The government has published the first progress report of its landmark 25 Year Environment Plan indicating that, in the first year, 90% of the plan's actions have been delivered or are being progressed. The 25 Year Plan sets out how the government will improve the environment over a generation by creating richer habitats for wildlife, improving air and water quality and curbing the scourge of plastic in the world's oceans.

The Plan highlights the Government's achievements in the last 12 months

- Cracking down on plastic waste by introducing plans to
- Laid the <u>Agriculture Bill</u> to introduce a fairer, more sustainable system of environmental land management.
- Committed to plans for the <u>first Environment Bill in 20</u> years.
- Safeguarding forests and woodlands by <u>kick-starting the</u> <u>creation of a Northern Forest</u> and <u>appointing a Tree</u> <u>Champion</u>.
- Protecting precious wildlife habitats launching a review to strengthen and enhance England's National Parks and Areas of Outstanding Natural Beauty.
- Protecting the marine environment by launching the Fisheries Bill, and introducing one of <u>world's toughest</u> <u>bans on microbeads</u> and consulting on the creation of <u>41</u> <u>new Marine Conservation Zones</u>.
- Put the UK ate the forefront of combatting the illegal wildlife trade through introducing <u>one of the world's</u> toughest ivory bans and <u>hosting the global Illegal Wildlife</u> <u>Trade Conference in London</u>.
