Legislation



The Ecodesign for Energy-Related Products and Energy Information (Amendment) Regulations 2019

These Regulations amend the Ecodesign for Energy-Related Products Regulations 2010 and the Energy Information Regulations 2011 in order to comply with and reflect changes that have been made to European Union law.

These changes relate specifically to:

- The introduction of ecodesign requirements for servers and data storage products;
- The annulment of energy labelling requirements for vacuum cleaners.

Regulations 1 and 3 come into force on 03 October 2019 and Regulation 2 comes into force on 01 March 2020.

The Ecodesign for Energy-Related Products and Energy Information (Amendment) Regulations 2019

Invasive Alien Species (Enforcement and Permitting) Order (Northern Ireland) 2019

This Order comes into force on 1 December 2019. It relates to Regulation (EU) No. 1143/2014 on the prevention and management of the introduction and spread of invasive alien species ("the Principal Regulation") which came into force on 1 January 2015.

It imposes strict restrictions on a list of species known as 'species of Union concern'. These are species whose potential adverse impacts across the European Union are such that concerted action across Europe is required.

The restrictions mean that (subject to certain defences, or exemptions through permits or licences) species of Union concern cannot be imported into the EU, kept, bred, transported, placed on the market, used or exchanged, allowed to reproduce, grown or cultivated, or released into the environment. There are currently 66 species on the Union list: 30 animals and 36 plants.

Public Consultation - Management measures for widely spread Invasive Alien Species (IAS) in Northern Ireland

The impact of invasive alien species (IAS) on our domestic and global biodiversity are severe and growing. They challenge the survival of some of our rarest species, damaging our sensitive ecosystems and have an impact on a range of industries and networks, including farming, the building industry and our waterways.

The Department of Agriculture, Environment and Rural Affairs (DAERA) is committed to taking action in dealing with the spread and impact of invasive alien species.

The purpose of this consultation is to obtain public views on the management measures being considered by DAERA.

The responses will help DAERA develop its thinking in this area so that it can put in place processes that will allow for effective action to be taken to manage species of union concern that are widely spread in Northern Ireland.

This Public Consultation is live from Wednesday 11th September 2019 for a period of six weeks. Environment Strategy for Northern Ireland – Public Discussion Document

The Department of Agriculture, Environment & Rural Affairs (DAERA) is seeking views on the potential scope, scale and ambition of Northern Ireland's first environment strategy. Northern Ireland has never had an overarching environment strategy but the Department believes one is now needed to develop an effective and holistic approach that will deliver real improvements for many decades to come.

The consultation closes on the 23 December 2019. All of the responses received will be carefully analysed and will be used to inform a future Minister's deliberations on the content of the Environment Strategy for

Northern Ireland.

Updates

F-gases and ozone depleting substances (ODS) Announcement

Action needed by 31st Oct 2019 if businesses/employees possess certificates for work with F-gases or ozone depleting substances in products/equipment and work in the Republic of Ireland's jurisdiction



If the UK leaves the EU without a deal, certificates gained from a UK-based certification body will no longer be valid for F-gas/ODS work in the Republic of Ireland ("Rol").

Businesses working in the RoI with F-gases or ODS in equipment, even if just partially, may therefore need to take action before 31st October 2019. This would apply to both company and individual certificates.
