The Genetically Modified Organisms (Deliberate Release) (Amendment) Regulations (Northern Ireland) 2019

These Regulations amend the Genetically Modified Organisms (Deliberate Release) Regulations (Northern Ireland) 2003 to implement the requirements of Directive (EU) 2018/350.

Directive (EU) 2018/350 introduces more detailed rules in respect to the environmental risk assessments which are to be made before the release of Genetically Modified Organisms (GMOs). With a focus on the information required before the release of Genetically Modified Higher Plants.



The Waste Regulations (Northern Ireland) 2019

The Waste Regulations (Northern Ireland) 2019 update relevant waste legislation to ensure that the requirements of the Waste Framework Directive have been met. In particular, the Regulations substitute references to the Waste Management Strategy with references to the Waste Management Plan (published by DAERA in 2019).

The programme is also aimed at supporting and promoting resource efficiency and the sustainable use of resources in Northern Ireland, whilst ensuring a shift towards a more circular economy.

Changes to Record Keeping for High Phosphorous Poultry Manure

The Department of Agriculture, Environment and Rural Affairs has published a timely reminder of the changes to record keeping for High Phosphorous poultry manure. Last year saw a revision of nitrogen and phosphorous excretion rates for poultry systems. The changes to Nutrients Action Programme will affect some poultry producers and involve extra record keeping requirements for the farms in question.

Cross Compliance 2020

The Department of Agriculture, Environment and Rural Affairs has published new verifiable standards booklets setting out the requirements that must be met under each of the Statutory Management Requirements (SMR) and Good Agricultural and Environmental Condition (GAEC). As these standards may change from year to year it is important, if you are affected, that you read these documents to familiarise yourself with the requirements.

Recent changes include:

Nitrates Action Programme Regulations (Northern Ireland) 2014 (as amended) and the Phosphorus (Use in Agriculture) Regulations (Northern Ireland) 2014 have now been replaced by the Nutrient Action Programme Regulation (Northern Ireland) 2019 (as amended). Revisions have been made to SMR1 and GAEC1.

SMR6: Pig Identification and Registration.SMR7: Cattle Identification and Registration.SMR8: Sheep and Goat Identification and Registration.
