The Environment Bill

The Environment Bill was introduced into parliament on 15 October 2019. It was re-introduced to parliament following a general election on 30 January 2020. The Environment Bill 2020 sets out how the UK Government plan to protect and improve the natural environment in the UK. The Bill covers:

- Environmental governance
- Resources and waste management
- Improving air quality
- Sustainable water resources
- Chemicals regulation
- Local environmental action

Waste Prevention Programme for Northern Ireland 2019

The Department of Agriculture, Environment and Rural Affairs is seeking views on the Waste Prevention Programme for Northern Ireland 2019, aimed at maintaining a downward trend in waste arisings, which in turn will have a significant impact on meeting the EU landfill diversion targets. The programme is also aimed at supporting and promoting resource efficiency and the sustainable use of resources in Northern Ireland, whilst ensuring a shift towards a more circular economy.

Consultation – Significant Water Management Issues (SWMI) in Northern Ireland

A new report has recently been published by the Department of Agriculture, Environment and Rural Affairs (DAERA), which highlights how our water environment remains under pressure from human activity, with the main pressures coming from agriculture and waste water related impacts. This report presents the significant water management issues facing Northern Ireland in the third cycle river basin management plan based on analysis by the Northern Ireland Environment Agency.

Through this Consultation you, all stakeholders and members of the public are invited to give your views on:

- What you think are the significant water management issues in Northern Ireland?
- How you think we can all work together to address these issues for the overarching benefit of all the citizens of Northern Ireland?
- What measures you think should be progressed and how these measures (actions) can be delivered?

Updates

2020 Nutrients Action Programme (NAP) derogation are now open

Applications for a derogation up to 250kg of Nitrogen per hectare per year have now opened under the Nutrient Action Programme (NAP) NI 2019.

The exemption is subject to farms meeting designated requirements. However, once these have been approved, farms may operate above the 170kg limit to a maximum of 250kg hectare per year for grazing livestock manure.

Changes to the nitrogen excretion rate values for some livestock types as of January 1, 2020, means that some farms who previously did not require a derogation, may now require one in order to continue operating at existing stocking levels and to avoid incurring a penalty under cross-compliance rules.

The closing date for new applications and 2019 account submissions will be 31 March 2020

Cross Compliance 2020

The Department of Agriculture, Environment and Rural Affairs has published new verifiable standards booklets setting out the requirements that must be met under each of the Statutory Management Requirements (SMR) and Good Agricultural and Environmental Condition (GAEC). As these standards may change from year to year it is important, if you are affected, that you read these documents to familiarise yourself with the requirements.

Recent changes include:

Nitrates Action Programme Regulations (Northern Ireland) 2014 (as amended) and the Phosphorus (Use in Agriculture)
Regulations (Northern Ireland) 2014 have now been replaced by the Nutrient Action Programme Regulation (Northern Ireland)
2019 (as amended). Revisions have been made to SMR1 and GAEC1

SMR6: Pig Identification and Registration.


SMR7: Cattle Identification and Registration.

SMR8: Sheep and Goat Identification and Registration.

The Environment Fund 2020/21 uses the proceeds of the carrier bay levy, which was introduced in 2013, to enable not-for-profit organisations and councils to deliver key environmental outcomes across Northern Ireland. Among the initiatives to be funded are





projects to recruit and train volunteers for large scale bird monitoring surveys; carry out habitat and species conservation activities; maintain and promote long-distance walking routes and encourage recycling.
