

New Legislation



The Waste (Fees and Charges) (Amendment) Regulations (Northern Ireland) 2020

These Regulations, will come into operation on the 15th July 2020. They increase fees and charges in relation to the processing of applications for the registration of brokers, dealers and carriers of waste and the processing of applications for the registration of exemptions from waste management licensing. The purpose of the fees and charges is to recover the costs incurred by NIEA in carrying out its function in relation to processing applications for these registrations.
