

## Agriculture (Retained EU Law and Data) (Scotland) Bill

This bill will allow Scotland to keep the EU's Common Agricultural Policy (CAP). It creates powers that enable Scottish Ministers to retain the ability to make improvements to the CAP scheme following Brexit.

## The Road Vehicle (Approval) Regulations 2020

This instrument provides for enforcement in the United Kingdom of Regulation (EU) 2018/858 on road vehicle type approval.

The type approval regime ensures that new cars, buses and goods vehicles comply with high standards of safety and environmental protection. It was enhanced in 2018, with improved powers of oversight and new requirements to ensure more thorough testing.

The Regulations come into force on 01 September 2020 Read more here >>>



#### **SEPA Consultations:**

Consultation on amendment of the conditions allowing the receipt of radioactive waste and contaminated items

The purpose of this consultation is to seek views on SEPA's proposal to vary a bespoke condition included in some permits granted under the Environmental Authorisations (Scotland) Regulations 2018 (EASR) on the receipt of radioactive waste and the holding of contaminated items.

The consultation closes on 09 September 2020.

#### **Consultation on the Emission Trading Scheme charges**

This consultation document outlines the proposed changes for the fees SEPA charge for regulating installations regulated under the UK Emissions Trading System/Carbon Emissions Tax from 2021.

This scheme will replace the Greenhouse Gas Emissions Trading Fees and Charges (Scotland) Scheme 2015 as amended, which covered charging under the EU Emissions Trading System.

The consultation closes on 18 September 2020.

### £300,000 for hydrogen innovation

The Scottish Government is investing £300,000 in a new hydrogen accelerator, which will be located at the University of St Andrews. This new initiative will propel innovations in hydrogen technology and encourage knowledge sharing to support transport applications and sustainable mobility.

The hydrogen accelerator will help maximise the economic opportunities from the shift to zero or ultra-low emission mobility solutions.

The submission process is free and opens on Monday 03 August 2020.


