



# The Offshore Chemicals and Offshore Petroleum Activities (Oil Pollution Prevention and Control) (Coronavirus) (Amendment) Regulations 2020

These regulations modify existing legislation to remove the requirement for offshore oil and gas operators to make relevant documents available for public inspection at a specified address within the United Kingdom, where the effects of coronavirus, including any restrictions on movement, mean that it is not reasonably practicable for the public to be able inspect documents in this way.

#### Consultation on the marine fish farm charges

#### Proposed Revision of Radioactive Substances Activities Standard Condition C.4.1.

This consultation looks at SEPAs proposal to revise condition C.4.1 of the standard conditions for radioactive substances activities (transfer of radioactive waste outside of the United Kingdom) made under the Environmental Authorisations (Scotland) Regulations 2018 (EASR) regarding the authorisation to transfer radioactive waste to a person out with the United Kingdom.

The consultation closes on 18 December 2020.

# Stay compliant. Protect the environment.

#### Waste disposal: compliance is non-negotiable

The Scottish Environment Protection Agency (SEPA) is reminding businesses to only engage the services of authorised waste collectors as they clamp down on businesses using social media to promote their services.

SEPA officers are monitoring Scottish social media for illegal waste collectors or operators and are acting where appropriate, with our enforcement team targeting criminals and chancers using social channels.

If your business is being offered cut price waste clearance services in a deal that sounds too good to be true, it probably is and could lead to a fine if your waste is then subsequently illegally dumped. Fly tipping is not only unsightly but, depending on the nature of the waste, it can also be hazardous to health and cause environmental damage. Fly tipping is a serious offence with significant consequences and those caught risk a fine of up to £40,000.

If you produce, transport or store waste you have a legal responsibility to make sure it's recycled or managed properly. Your responsibility doesn't stop when you contract another supplier in the supply chain, you remain responsible.

Businesses and the public can check if a carrier is registered by visiting SEPAs <u>registered waste carriers</u> <u>and brokers website</u>. If your business is experiencing pressures on commercial operations due to the impacts of COVID-19 visit <u>coronavirus.sepa.org.uk/waste</u>
